The regular meeting of the Central Montcalm Public School Board of Education was called to order by President Simpson in the High School Media Center on October 19, 2015 at 7:00 p.m.

Present: Bill Simpson, Jim Rogers, Brennen Bowen, Todd Giles, Bill Collins and Brandy Ryan.

The regular meeting minutes of September 21, 2015, were approved as submitted.  
The Finance Report for the month ended September 30, 2015, was approved.

Motion by Collins, supported by Grossbauer, to ratify the payment of bills from September 18 to October 14, 2015, in the amount of \$452,486.21. Those in favor 7, opposed 0. Motion carried.

Superintendent Meinhardt shared the highlights of the District calendar with the Board. Ms. Amanda Garber of Abraham & Gaffney presented the FY 2014-2015 financial audit. Introductions were made of the foreign exchange students by Ms. Sheena Sanders.

Ms. Angie Smith shared some concerns with student behavior at the elementary school. Ms. Martha Smith inquired had concerns with students bringing weapons to school. The Board accepted an apology from a minor student in reference to an incident at the Upper Elementary.

Motion by Grossbauer, supported by Ryan, that the Consent Agenda be approved, as follows:

1. To employ Cortney O'Brien as a probationary teacher, effective the 2015-2016 school year, contingent upon criminal history and unprofessional conduct checks.
2. To employ Chelsea LaJoye as a probationary teacher, effective the 2015-2016 school year, contingent upon criminal history and unprofessional conduct checks.
3. To employ Amber Prout as a part-time Driver, effective September 8, 2015, contingent upon unprofessional conduct and criminal history records checks.
4. To employ Louis North as a part-time driver, effective October 12, 2015, contingent upon unprofessional conduct and criminal history records checks.
5. To accept recommendations of the Salary Committee, effective September 27, 2015.

Those in favor 7, opposed 0. Motion carried. Introductions were made of Cortney and Chelsea.

Motion by Collins, supported by Giles, that the Board of Education of the Central Montcalm Public School District accept the audit for the 2014-2015 Fiscal Year. Those in favor 7, opposed 0. Motion carried.

Motion by Giles, supported by Ryan, that Commencement for the Class of 2016 be established for Sunday, May 22, 2016 at 2:00 p.m., in the CMHS Gymnasium. Those in favor 7, opposed 0. Motion carried.
